### **Description of necessary first aid measures**

**Eye contact**

# Specific hazards arising from the chemical

: Highly flammable liquid and vapor. Runoff to sewer may create fire or explosion hazard. ### Section 7. Handling and storage

#### **Precautions for safe handling**

#### **Protective measures**
