## Handling and Application

**PREPARATION**: Clean surface with **3837() SEM SOLVE**. Remove any loose paint, rust, oil and grease. Blow off and clean again with **3837()**.



## APPLICATION: Aerosol:



Distance: 6-8"

Coats: 2-3 medium wet Flash time: 3-5 minutes

**NOTE**: If clogging develops, remove spray button with a twisting motion and clean with material compliant with VOC regulations in your area. Do not stick pin or other object into can. Gently replace spray button with top of can and spray button pointed away from you.

**NOTE**: After each use, turn can upside down and spray several seconds to clear spray tip.



#### Bulk:

Attach **40524** to **71101 ECONOMY COATING GUN**. Using 35-40 psi, apply 2-3 medium coats allowing 3-5 minutes flash time between coats. Clean gun immediately after use with solvent compliant in your area.

**NOTE**: Final texture, flash times, and dry times are affected by gun distance, air pressure, temperature, and humidity.

### 39523 RUBBERIZED UNDERCOATING and 4052( ) LOW VOC RUBBERIZED

**UNDERCOATING** should be stored in a cool dry place with adequate ventilation away from heat, sparks and flames. The shelf life for **39523** and **4052()** is 3 years when stored under normal conditions.
